Hence, the coastal regions will see the sea level rise through the 21st century and it will contribute to more frequent and severe coastal flooding and coastal erosion. Along with this, extreme sealevel events that were previously seen once in a hundred years, could also happen every year by the end of the

century," she said. The report also observed that it is indisputable that human activities are causing climate change, making extreme climate events more

frequent and severe. "Human influence has led to ocean warming since the 1970s and ocean acidification along with changes in the frozen areas of the planet. There has been a 40% decrease in Arctic Sea ice since the 1990s and spring snow cover has decreased since

the 1950s," it said. The authors of the report said in the next 20-30 years, India will not see much increase in the rainfall beyond internal variability change, but both annual as well as the summer monsoon precipitation will increase by the end of the 21st century.

"While there is not much model agreement on the changes in the heavy precipitation events, we can definitely say that hot extremes are projected to increase and cold extremes are projected to decrease in the 21st century," Panickal said.

She said if large-scale reductions are not made in the greenhouse gas emissions, limiting global warming to 1.5 degrees or 2 degrees Celsius will be beyond reach. PTI

Hindu Kush to continue shrinking' New Delhi: Glaciers in the

'Glaciers in

Hindu Kush Himalayan (HKH) region will keep shrinking and the snow cover will retreat to higher altitudes, the latest IPCC report said on Monday. One of the authors of the

report, Krishna Achuta Rao, said in the HKH region, the snow cover has reduced since the early 21st century and glaciers have thinned, retreated and lost mass since the 1970s. However, he said, the Ka-

rakoram glaciers have either slightly gained mass or are in an approximately balanced state. According to the report,

mountain glaciers will continue to shrink and permafrost to thaw in all regions where they are present.

Moraine-dammed lakes are normally formed near glacier terminus. These lakes can burst due to excessive melting and can cause floods in the valleys. Many such floods have been reported in the Himalayas and other parts of the world.

Another author of the report, Swapna Panickal, said that reducing emissions now will not stop the retreat of glaciers as it is a slow

New Delhi: The Supreme Court Monday said the Jharkhand High Court Chief Justice will monitor weekly the progress made in the CBI probe into the alleged mowing down of a judge by a vehicle on July 28 in Dhanbad, and observed that the sealed cover report of the central agency did

not contain much details. A bench of Chief Justice NV Ramana and justices Vineet Saran and Surya Kant asked the CBI to file its report weekly with the high court where the bench headed by the Chief

Justice would monitor it. The top court had on July 30 taken suo motu cognizance of the "unfortunate" "sad demise" of the judge in "gruesome incident" and had sought a status report within a week from Jharkhand's Chief Secre-

tary and the DGP on probe. CCTV footage showed that District and Sessions Judge-8 of Dhanbad court, Uttam Anand, was jogging on one side of a wideroad at Randhir Verma Chowk early on July 28 when a heavy auto-rickshaw veered towardshim, hit him from behind and fled the scene. PTI
