Notice is hereby given that approval of Members of Indo Count Industries Limited ("the Company") is sought through Postal Ballot/Electronic voting (e-voting) pursuant to Section 110 of the Companies Act, 2013 (the "Act") read with Rule 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification or re-enactment thereof for the time being in force) and other applicable provisions, if any and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "Listing Regulations"), for the Resolutions appended below for sub-division of Equity Shares and consequential amendments to the Memorandum of Association of the Company.

Item No. 1:

Sub-division of Equity Shares of the Company from the Face Value of ₹10/- per share to Face Value of ₹2/- per share

To consider and, if thought fit, to pass the following resolution, as an **Ordinary Resolution**:

"RESOLVED THAT pursuant to the provisions of Section 61 (1) (d) and other applicable provisions, if any, of the Companies Act, 2013 (including any statutory modification or re-enactment thereof for the time being in force) and in accordance with the provisions of Memorandum and Articles of Association of the Company and subject to the approvals, consents, permissions and sanctions, if any, required from the concerned authority(ies) or bodies,

RESOLVED FURTHER THAT on sub-division, 5 (Five) Equity Shares of Face Value of ₹ 2/- (Rupees Two only) each be allotted in lieu of existing 1 (One) Equity Share of ₹ 10/- (Rupees Ten only) each, subject to the terms of the Memorandum and Articles of Association of the Company and shall rank pari-passu in all respects and carry the same rights as the existing fully paid Equity Shares of ₹ 10/- (Rupees Ten only) each of the Company;

Alteration of Capital Clause of Memorandum of Association of the Company

To consider and, if thought fit, to pass the following resolution, as an **Ordinary Resolution**:

"RESOLVED THAT pursuant to the provisions of Sections 13, 61 and other applicable provisions of the Companies Act, 2013 (including any statutory modifications or renactment thereof for the time being in force) and Clause V of the Memorandum of Association of the Company relating to Share Capital be substituted by the revised clause as given below:

V. Authorised Share Capital of the Company is ₹60,00,00,000/-(Rupees Sixty Crores only) divided into 27,50,00,000 (Twenty Seven Crores Fifty Lacs Only) equity shares of ₹2/- each and 50,00,000 (Fifty Lac Only) preference shares of ₹10/- each.

RESOLVED FURTHER THAT the Board of Directors of the Company and Company Secretary be and are hereby authorised to settle any questions, difficulty or doubt arising out of and incidental thereto and to execute all agreements, deeds, applications, documents and writings that may be required, on behalf of the Company and generally do all such acts, deeds, matters and things as may be necessary, proper and expedient and incidental for the purpose of giving effect to this resolution."

- 1. The Explanatory Statement pursuant to Section 102 of the Companies Act, 2013 in respect of Item Nos. 1 and 2 is annexed hereto and forms part of this Notice.
- The Notice is being sent under permitted mode to all the members, whose names appear in the Register of Members / Record of Depositories as on 19th August, 2016.
- 3. The Board of Directors of the Company has appointed Mr. Virendra Bhatt, Practising Company Secretary, as Scrutinizer for conducting the Postal Ballot process (including e-voting process) in a fair and transparent manner and to scrutinize the completed postal ballot forms received from the members. After completion of his scrutiny, the Scrutinizer will submit his report to the Executive Chairman of the Company.

- 4. The resolutions will be taken as passed effectively on the date of announcement of the result by the Executive Chairman, if the result of the Postal Ballot indicates that the requisite majority of the shareholders has assented to the resolutions. The result of the Postal Ballot will be declared on 30th September, 2016. After declaration, the result of the Postal Ballot will be published in the newspapers and will also be posted on the Company's website www.indocount.com and on the website of BSE Limited i.e www.bseindia.com and National Stock Exchange of India Limited i.e. www.nseindia.com where the shares of the Company are listed.
- 5. A copy of each of the documents referred to in the accompanying Explanatory Statement is open for inspection at the Corporate Office of the Company between 10.00 a.m. to 12.00 Noon on any working day excluding Saturday and Sunday till the closure of working hours of 29th September, 2016 (last date for receiving Postal Ballot Forms by Scrutinizer).
- The Postal Ballot form and the self-addressed business reply envelope are enclosed for use of members. Members are requested to carefully read the instructions as mentioned hereinafter before exercising their vote.
- 7. The voting rights of the members of the Company shall be reckoned as on the cut-off date i.e. 19th August, 2016.
- 8. Kindly note that the members can opt for only one mode of voting i.e., either by physical postal ballot form or e-voting. If the members opt for e-voting, then they should not vote by postal ballot form and vice versa. However, in case members cast their vote by postal ballot form and e-voting, then voting done through e-voting shall prevail and voting done by Postal Ballot Form will be treated as invalid.

Instructions for Voting through electronic means:

In compliance with the provisions of Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company has also provided e-voting facility through Central Depository Services (India) Limited (CDSL) as an alternate, for its members to enable them to cast their votes electronically instead of voting through Postal Ballot Form(s).

The e-voting period begins on Wednesday, 31st August, 2016 at 9.00 a.m. (IST) and ends on Thursday, 29th September, 2016 at 5.00 p.m. (IST).

During this period, shareholders of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date i.e. Friday, 19th August, 2016 may cast



their votes electronically. The e-voting module shall be disabled by CDSL for voting after 5.00 p.m. (IST) on Thursday, 29th September, 2016.

EXPLANATORY STATEMENT UNDER SECTION 102 (1) OF THE COMPANIES ACT, 2013

Item Nos. 1 and 2

The Equity Shares of your Company are actively traded on National Stock Exchange of India Limited and BSE Limited. The operations of the Company have grown during the years. The market price of shares of the Company has also increased significantly. In order to improve the liquidity of the Company's shares in the stock market and with a view to encourage the participation of small investors by making Equity Shares of the Company affordable, the Board of Directors at its meeting held on August, 23, 2016 considered and approved sub-division of One Equity Share of the Company of face value of ₹ 10/- each into Five Equity Shares of face value of ₹ 2/- each subject to the approval of the Members of the Company and any other statutory and regulatory approvals, as applicable. The Record Date for the aforesaid sub-division of Equity Shares will be fixed after approval of the Members is obtained.

Presently, the Authorised Share Capital of your Company is ₹ 60,00,00,000/- divided into 5,50,00,000 Equity Shares of ₹10/- each and 50,00,000 Preference Shares of ₹ 10/- each.

The sub-division as aforesaid would require consequential amendments to the existing Clause V of the Memorandum of Association of the Company as set out in Item No. 2 of the Notice respectively to reflect the change in face value of each Equity Share from ₹ 10/- each to ₹ 2/- each.
