Later the company contested the same in Supreme Court and vide order dated 24th July 2020, the appeal is dismissed. Thus, in the previous quarter i.e. quarter ended 31st March 2021, the company has recognised the liability of Rs. 25 lakhs payable towards the penalty imposed by SEBI on account of non-redressal of investor grievances.

The regulatory approval has been received for conducting "a phase 2 randomised, multi-centric, clinical trial of heterologus prime-boost combination of SARS-CoV-2 vaccines to evaluate the immunogenicity and safety of BBV152 (Covaxin) with BBV154 (adenoviral intranasal Covid-19

vaccine) in healthy volunteers". This is the first of its kind Covid-19 jab to undergo human clinical trials in India, it said.

BBV154 is an intranasal replication-deficient chimpanzee adenovirus SARS-CoV-2 vectored vaccine. Bharat Biotech has in-licensed technology from Washington University in St Louis, US, it said.

Data from the UK shows the effect of vaccination on the ongoing Delta-driven third wave in terms of cases and deaths. On January 20, when the immunisation drive was a few weeks old, the country registered 38,746 cases and 1,824 deaths. In contrast, on August 10, with more than 50% of the population fully vaccinated, the UK had 23,269 cases and 104 deaths.

Dr Shashank Joshi, a member of the state Covid-19 task force, said, "Global data has shown Delta strains have 'immune escape'. Hence, we need to continue using masks." Moreover, Deltamake generalisations," Dr Joshi added.

The basic principle of vaccination is they provide wide spectrum immune protection. "The protection is a combination of responses mediated by T cells and memory B cells and is often long-lasting. Therefore, vaccines might be preparing the immune system for a wide array of potential variants," said Bengaluru-based epidemiologist Dr Giridhar Babu.

rusing the orders of the tribunal which uses watermarks in its or-Eder said, "these watermarks ma-Ekes the orders unreadable especially for the visually challenged because it is not machine readable. It impacts the access to justice to the Edisabled".

Recounting his experience, EJustice Chandrachud said he had a law clerk last year, who was a



Rhodes Scholar and blind and he used to face difficulty in reading these orders as these were not machine readable. "Earlier, we had taken up the issue of watermarks with the high courts. Now we will take up the issue with the tribunals, including NGT. Due to the watermarks, I am not able to read these orders comfortably. Navigating through these watermarks is a nightmare," Justice Chandra-

chud said. He said tribunals do not come under the Supreme Court and an e-committee which is headed by him will take up the issue with the
