## **Instructions for voting through Postal Ballot Form**

- (vi) The Vote through Postal Ballot Form shall not be exercised by a proxy.
- (vii) Duly completed Postal Ballot Form should reach the Scrutinizer not later than the close of working hours on 29<sup>th</sup> September, 2016. All Postal Ballot Forms received after this date will be strictly treated as if the reply from such shareholder has not been received.
- (viii) In case of shares held by Companies, Trusts, Societies, etc., the duly completed Postal Ballot Form should be accompanied by a certified copy of board resolution/ authorization together with the specimen signature(s) of the duly authorized signatories if not registered with the Company.

- (xii) A member may request a duplicate Form, if so required. However, the duly filled in duplicate Form should reach the Scrutinizer not later than the date specified at item no. (vii) above.
- (xiii) Members are requested to fill in the Postal Ballot Form with indelible ink and not by any erasable writing mode.
